01. The method of procurement is Single Stage - Two Envelope Procedure **(Technical Proposal & Financial Proposal)**
02. The Bidder must have 15 years of experience in providing security services to well reputed Organizations including Universities.
03. The Bidders should have successfully completed at least 05 similar projects in last three years in large organizations.
04. The Bidder must be currently providing security services to at least three universities on continuous basis since last three years.
05. Marks will be given as per Evaluation Criteria.
06. All documents should be clearly legible and attested from any gazette Govt. Officer (grade 17 or above) with Name Stamp.
07. Documents without attestation or attestation without Name of Officer will not be considered for qualification.
