RE-NOTICE INVITING TENDER

The Begum Nusrat Bhutto Women University Sukkur invites Bids (Tenders) from interested, eligible, qualified and experienced Bidder(s) through EPADS (E-Pak Acquisition & Disposal System) on a Single Stage - Two Envelope Procedure as per SPPRA's Rules for the following works:

3. Eligibility and Qualification Criteria:

- a) Valid registration with Pakistan Engineering Council (PEC):
 - i. Category C-6 or above
- b) Valid registration with Sindh Revenue Board (SRB).
- c) NTN Certificate activated status in Federal Board of Revenue (FBR).
- d) Copy of CNIC of owners/proprietors.
- e) Experience in similar nature of work(s) executed during the last five years: i. At least one similar nature of work having minimum cost 80% of the estimated cost of the work; or ii. At least two similar nature works each having minimum cost 50% of the estimated cost.
- f) Average Annual Financial Turn-over not less than equivalent cost of the scheme/project during last five years.
- g) List of similar nature of building works with satisfactory Completion Certificates along with Letters of Award issued from the Procuring Agency for last five (05) years.
- h) Details of equipment, machinery and transport owned/leased/hired by the bidder related to the building construction with documentary evidence.
- i) Financial Statement (Summary), Income Tax Returns, Bank Statements and Audited Reports for last three (03) years.
- j) List of litigation (if any) their nature and status/outcomes.
- k) A separated Affidavit on original stamp paper of at least Rs.100/- (duly notarized) to the effect that the bidder is not black listed and not involved in any litigation and arbitration with any Government Procuring Agency and bidder has not abandoned any work.
- l) The bidders shall have to submit complete details of Engineering and Technical personnel along with CVs (duly signed by concerned person with attested copies of testimonials and having relevant experience).
- m) All documents required should be clearly legible and attested from any gazetted Govt. officer otherwise bid cannot be considered for qualification. Stamp without name of officer are not eligible.
- n) Bidders shall have to submit separated affidavit on original stamp paper of at least Rs.100/- (duly notarized) to the effect that:
 - i. All the documents' /particulars/ information furnished are absolutely true & correct.
 - ii. Declaring that there is no involvement in any corrupt, fraudulent and collusive practices.

- iii. If, at any stage, the information is found to be bogus, fake, forged, or counterfeit, action shall be taken in accordance with the applicable rules.

- i. Interested bidders are required to get registered themselves on EPAD system in the link <https://sindh.eprocure.gov.pk/#/supplier/registration> for submission of electronics bids. - ii. The bids prepared in accordance with the instruction given in the bidding document must be submitted on EPADS. The original instruments of tender fee (non-refundable) and bid security, in shape of Call Deposit issued by any scheduled bank of Pakistan, in favour of, "The Begum Nusrat Bhutto Women University, Sukkur" must reach the Procuring Agency (the undersigned) in the sealed envelope prior to the deadline of submission of bids. The technical bids will be opened by the Procurement Committee on the same day at 11:00 am, in presence of the bidder(s) or their authorized representative who wish to be present. After completion of Technical Process, the Financial Bids of technically qualified bidders will be opened and uploaded on EPADS, accordingly.
6. The bidder must submit hard copies of the documents. Submission of hard copies is mandatory.
